- a)and b) DCo reported that there were 115 stamps used or returned. The final number of collated returns was 196, with some containing more than one set of results. The tally of results has been completed and circulated as has the lists of comments that were added to the questionnaires. Agree that PCo will convert all tallies to a percentage of respondents answering each sub question. The total number of papers with added comments was 130 and the distribution of those comments by sub question is as table below. Only 4 respondents commented on every question and 8 of the back page comments were 'thank you' etc. Average number of comments for these questionnaires was 3.75.

This will be undertaken on a date in August to be agreed with an independent observer present who will be paid at an appropriate rate.

There was a peak on The Warbler publication day and a tendency for returns every other day. Agreed that email addresses that had been submitted would be logged for use as and when appropriate.

Footnote from P.Corbett

I have added percentages to response sheet where appropriate (some of 2b and Q6 not appropriate).

I have reviewed response rates from research statistics and they vary widely. From a simple postal survey to strangers you should expect from 2 to 20% responses, clinical questionnaires to professionals expect 50 to 60% response, 7 page (called long) research questionnaires 42%. I think that our response rate can be regarded as statistically significant from a quantitative point of view.

I have also approximately interpolated population demographics from the 2011 census and added them to the table at the bottom of the questionnaire response sheet reproduced below. By
