Minutes of the meeting held in the Village Hall on Wednesday 15th April 2015.

Present; Cllr. D. Corbett (Chair), Cllr L.Spindler (Vice Chair) Cllr. H. Phillips, Cllr. R. Dillaway, Cllr. J. Tate, Cllr. A. Edwards, Cllr. A. Alder, Cllr. Alan. Spindler, County Cllr. M. Gower, Richard Day (Clerk) and 6 Parishioners attended the meeting.

- 1. Apologies were received and accepted from Cllr. M. Gasper and Cllr.D Wilkinson, Cllr. Alastair Spindler did not attend the meeting.
- 2. Cllr. Phillips declared a non pecuniary interest in agenda item 11 (i)
- 3. There were no requests for dispensation to vote.
- 4. The minutes to the meeting of 18/03/2015 were proposed for acceptance by Cllr. R. Dillaway, seconded by Cllr. A. Edwards and unanimously approved.

5. Clerk's Report

- Nomination delivery and statutory duties re Parish Council Elections completed within timescales.
- Wenhaston will be uncontested and a summary of nominations has been posted.
- Year end accounting procedures completed and audit documentation, including Annual Return and Governance Statement, prepared for delivery tomorrow morning. (Refer to RFO Report)
- Progress report on repair to roadway to Sports Pavillion/Play area. Notices to be posted outlining closure on 26th and 27th May and possibly 28th May.
- VHMC have obtained estimate for required work to install defibrillator. This is £165.00 plus vat. A grant of £100.00 will be made available from Co-op to partially fund and a copy of the agreement regarding care/maintenance has been forwarded to VHMC for signature should Parish Council wish to proceed. ACTION. Proposal to proceed from ClIr Corbett seconded by ClIr Alder, all voted in favour. Clerk to advise Co-Op and agreement to be forwarded to VHMC for signature.
