Minutes of the meeting of the Parish Council held on 19/04/2023 at 7.30pm. in the Village Hall.

Present; Cllr. P Wildish (Chair), Cllr. A Musk (Vice chair) Cllr. J Townsend, Cllr. H Phillips, Cllr. G Leech, Cllr. C Way, Cllr. M Welby and Clerk Richard Day.

- 1. Chair welcomed all to meeting. Apologies received and accepted from County Councillor Smith and Cllrs. Watson, Canham, Stammers and Mann.
- 2. Cllr. Stammers had declared interest in agenda item 12(ii) prior to meeting but would take no part in discussion or decision.
- 3. There were no requests for dispensation to vote.
- 4. Minutes to the meeting held on 22/3/23 were proposed for acceptance by Cllr. Musk seconded by Cllr.Townsend and agreed unanimously.
- 5. CLERK REPORT.
  - (i) Election nominations completed and I am advised that we are able to co opt to fill vacancies.(ii) APM agenda has been prepared and published.
    (iii)Telephone box restoration and return has now been undertaken and ClIrs. Mann and Townsend will complete remaining work with the interior fittings prior to the display being set up.(iv) I attended a meeting at Village Hall with VHMC and Chair following the attempted break in. Further meeting planned for 2/5/23 together with security advisers. (v) Application for Environmental Stewardship Scheme for Blackheath has been submitted in conjunction with SWT and WCG.
- 6. There were no matters arising from previous minutes.
- 7. No report from County Clir Smith.
- 8. No report from District Cllr Goldson.
- Items carried forward from previous meeting. (i) The proposal to consider improvements to street lighting at Narrow Way did not meet with support as it conflicts with stated objectives within the neighbourhood plan and also the resultant cost implications are significant.
- 10. Following a site meeting attended by Cllrs. Wildish and Leech and subsequent to a request from a Parishioner, the court at the multi sports area will be pressure washed to improve visibility of markings.
- 11. Coronation Plaque for possible installation will be investigated for cost after Cllr. Wildish has advised suitable wording to Cllr. Musk. (Carry forward.)
- 12. Planning. (i) DC/23/1151/FUL. Glengally, Blyford Lane, Wenhaston. Rear extension, new detached double garage and demolition of outbuildings. Unanimously supported. (ii) DC/23/1431/FUL. (Received post agenda production) Sprucefield, Blyford Lane, Wenhaston. Construction of new garage/secure store. Unanimously supported.

(ii) Qtr 4 Expenditure vs Budget figures produced and these confirm all areas within tolerance levels. (iii) Bank balances total £51692.00 prior to authorisation of payments of £1608.11 this month.
