### Introduction

The primary objective of internal audit is to review, appraise and report upon the adequacy of internal control systems operating throughout the council. To achieve this SALC adopt a predominantly systems-based approach to audit.

The council's internal control system comprises the whole network of systems established within the council to provide reasonable assurance that the council's objectives will be achieved, with reference to:

- the effectiveness of operations
- the economic and efficient use of resources

- compliance with applicable policies, procedures, laws, and regulations
- the safeguarding of assets and interests from losses of all kinds, including those arising from fraud, irregularity, and corruption
- the integrity and reliability of information, accounts, and data

### Methodology

When conducting the audit, the internal auditor may:

- conduct a selective assessment of compliance with relevant procedures and controls expected to be in operation during the financial year in order to be able to complete the Annual Internal Audit Report 2022/23 of the Annual Governance and Accountability Return (AGAR)
- review the reliability and integrity of financial information and the means used to identify, measure, classify and report such information
- review the means of safeguarding assets and, as appropriate, verify the existence of such assets
- appraise the economy and efficiency with which resources are employed, identify opportunities to improve performance and recommend solutions to problems
- review the established systems to ensure compliance with those policies, procedures, laws, and regulations which could have a significant impact on operations, and determine whether the council complies
- review the operations and activities to ascertain whether results are consistent with objectives and whether they are being conducted as planned



### Section 1 – proper bookkeeping

The internal auditor will look at the methods and processes used to manage the council's accounts and in particular that it provides clear data for reporting and monitoring purposes. This includes checking information is accurate, kept up to date, referenced and verified.

Is the ledger maintained and up to date? YES		The council uses an excel spreadsheet to form the basis of their accounting system detailing receipts and payments ensuring that the financial transactions of the parish council are accurately recorded.		
<i>Is the cash book up to date and regularly verified?</i>	YES	The cash book provides good evidence to support the council's underlying statements. Regular reports are generated and circulated to councillors detailing expenditure and income and the accounts reconciled to the bank statements showing good internal control.		
Is the arithmetic correct?	Partly Met	Cheques to the value of £806.01 were recorded as not cashed and therefore re- stated in the council accounts. The value has been incorrectly added to the receipt's column. As these were uncashed cheques, this was not an income received and should not appear in this calculation. <b>RECOMMENDATION:</b> The payment column stays as it is with the £806.01 shown as a minus figure, therefore cancelling out the value of the original payment. The income column needs to remove the value completely, from the detailed receipts where it is added in and the end calculation where it is cancelled out. This is not income.		



### Section 2 – Financial Regulation and Standing Orders

The internal auditor will check the date the Council conducted its annual review of both Standing Orders and Financial Regulations and in particular check if these are based on NALC'S latest model which include legislative changes.

YES	At a meeting on 26 <sup>th</sup> May 2022 the council carried out an annual review of its Standing Orders, these are available to view on the council's website and are based on the Model Standing Orders produced by NALC IN 2018 which take into account changes in legislation from those produced in 2013.
Are Financial Regulations up to date and reviewed annually?	YES	Financial Regulations were reviewed and agreed at a council meeting held 26 <sup>th</sup> May 2022. These are available to view on the council's website and are based on the NALC Model Financial Regulations 2019.
Has the Council properly tailored the Financial Regulations?	YES	The Financial Regulations have been tailored to the council.
Has the Council appointed a Responsible Financial Officer (RFO)? <sup>1</sup>	YES	In accordance with Section 151 of the Local Government Act 1972(d) (financial administration), at a meeting held 26 <sup>th</sup> May 2022, the council approved the clerk to be the Responsible Financial Officer as per the council's own Financial Regulations (1.8) which state that the Clerk is the RFO.

### Section 3 – Payment controls

The internal auditor will specifically check bank reconciliation including credit/debit cards and management approval processes and evidence that internal Financial Regulations (FO) are being followed. The internal auditor will examine how regular payments are managed and specifically seek evidence that these have been brought back to the Council for verification purposes especially where the actual payment made differs from the amount previously agreed. VAT should be clearly identified including evidence that claims have been correctly managed. The internal auditor will check if the Council has a clear understanding on eligibility in relation to the General Power of Competence and that s.137 has been correctly applied and managed.

Is there supporting paperwork for payments with appropriate authorisation?	YES	A selection of expenditure items was made, and cross checked against the cash book, invoices and bank statements. A list of payments is presented to councillors ensure formal approval of expenditure and this is correctly minuted. Invoices are signed and dates, with the cheque stubs initialled. This demonstrates good practice in that there are measures in place that help safeguard public money.
Where applicable, are internet banking transactions properly recorded and approved?	N/A	The council does not operate internet banking.
Is VAT correctly identified, recorded, and claimed within time limits?	YES	VAT is clearly identified in the cash book with the year-end total of £2,644.44 and a claim received of £3,091.78 from HMRC recorded May 2022.
Has the Council adopted the General Power of Competence (GPOC) and is there evidence this is being applied correctly? <sup>2</sup>	N/A	The council has not adopted the General Power of Competence.

S137 donations recorded are of a direct benefit to the electorate with payments made reported at the council meetings. <b>RECOMMENDATION:</b> Section 137 payments should be recorded separately from the subscriptions to allow a clear running total, ensuring funds spent are within the statutory limit.
Where applicable, are payments of interest and principal sums in respect of loans paid in accordance with agreements?	N/A	The council has no loans.

### Section 4 – Risk management

The internal auditor will expect to find evidence of the management of risks from identification of what those are for each individual Council through to how these will be managed and the controls in place to mitigate these and that these have been approved by the Council.

Is there evidence of risk assessment documentation?	YES	This was considered for the period under review at meetings of the council held 18 <sup>th</sup> January 2023 and 15 <sup>th</sup> February 2023.
Is there evidence that risks are being identified and managed?	YES	The council has taken steps to identify, assess and record the risks associated with its actions and decisions that could have financial or reputational consequences.
Does the Council have appropriate and adequate insurance cover in place for employment, public liability and fidelity guarantee <b>and</b> has been reviewed on an annual basis?	YES	Council has insurance in place under an Ansvar Policy which shows core cover for the following: Employer liability: £10m; Public/Products Liability: £10m; Fidelity Guarantee £100k. At a meeting held 21 <sup>st</sup> September 2022 the insurance cover was checked and agreed.

		Council also records Sports Pavilion Insurance which was reviewed and approved at a meeting of full council held 22 <sup>nd</sup> March 2023 and presented to the Internal Auditor. The level of Fidelity Guarantee meets the recommended guidelines which provides that the cover should be at least the sum of the year-end balances plus 50% of the precept/grants.
Evidence that internal controls are documented and regularly reviewed <sup>4</sup>	YES	At a full council meeting on 26 <sup>th</sup> May 2022 a councillor was nominated for the monitoring of the Internal Control. It was then detailed at meetings held 21 <sup>st</sup> September and 21 <sup>st</sup> December 2022 that reviews of the Internal Controls were checked and managed accordingly, in accordance with the Accounts and Audit Regulations 2015. This clearly demonstrates public finances are adequately protected and managed and evidence necessary steps have been taken to mitigate any risks identified. Documentation to support control procedures adopted by the council for payments helps protect the RFO and fulfils an internal control objective.
Evidence that a review of the effectiveness of internal audit was conducted during the year, including consideration of the independence and competence of the internal auditor prior to their appointment <sup>5</sup>	YES	The effectiveness of the internal audit was discussed by full Council and signed off at a meeting held 21 <sup>st</sup> December 2022. By reviewing the terms of reference and effectiveness for internal audit the council has followed guidance and demonstrates that it recognises that the function of internal audit is to test and report to the authority on whether its system of internal control is adequate.

Verify that budget has been properly prepared and agreed	YES	The budget for 2022/2023 was agreed and set at a meeting of full council on 17 <sup>th</sup> November 2022.
Verify that the precept amount has been agreed in full Council and clearly minuted	YES	The precept for 2022/2023 was set at £24,000 and formally approved at a meeting of full council on 17 <sup>th</sup> November 2022, then finalised at a meeting held 15 <sup>th</sup> December 2022.
Regular reporting of expenditure and variances from budget	YES	Reporting of expenditure and variances is conducted on a quarterly basis and recorded within the council minutes.
Reserves held – general and earmarked <sup>6</sup>	YES	The council accounts show a general reserve of £8,000 and an earmarked reserve of £43,692. Council is aware of the guidance as issued by Proper Practices which states that it is regarded as acceptable for a council's general (non-earmarked revenue) reserves to be equal to 3 to 12 months of Net Revenue Expenditure. There is no upper limit for Earmarked Reserves, but they should be held for genuine and intended purposes and their level subject to regular review and justification (at least annually).

- decide the form and level of detail of the budget;
- review the current year budget and spending;
- determine the cost of spending plans;

- review progress against the budget regularly throughout the year.

Is income reported to full council?	YES	Income is reported to full council and recorded within the minutes.
Does the precept recorded agree to the Council Tax Authority's notification?	YES	The receipt of the precept to the value of £24,000 was recorded in two separate payments in April and September.

YES	The payroll function for the year under review was carried out by SALC and is operated in accordance with HM Revenue and Customs guidelines. A clear audit trail should be available when items are purchased including minutes to evidence approval.
